It is hard to believe that in today's self-centred world, a person could leave his first Cambridge University job and a successful administrative career at the Indian Statistical Service, only to teach and guide Indian management students and researchers at the University of Burdwan, which is not considered a premium institution. He dedicated his life to this mission.
He knew his students couldn't quite compare with his academic achievements, such as his first-class first B.Sc. and M.Sc. degrees in Statistics from Calcutta University, being the recipient of the Sciencia Scholarship for being the first in B.Sc. among all science disciplines at Calcutta University, being a Fellow from IIM Calcutta, holding a PhD from Calcutta University, and completing a Post Doctoral program at a prestigious university in Canada. He was a father figure to many of his students and colleagues, who sought his advice for their professional and personal challenges. He departed from this mortal world in 2014, entering the realm of immortality.
Just like every year on 19th August, this year also, his students, friends, and family members celebrated his birthday through an online program. His students from prestigious organisations and institutions across the globe joined to recollect his memories and advice, which are like priceless pearls in their lives. Two of his students sang songs with great devotion, while his family shared his dedication and sweet memories. The program concluded with a beautiful rendition of a Rabindrasangeet by his wife, Dr Arundhati Roy.
